The Clinton County Commissioners met for a regular meeting on Wednesday, February 17, 2021 at 9:00 a.m. at the Clinton County Courthouse, 125 Courthouse Square, Frankfort, IN 46041.

IN THE MATTER OF THE ZILLOW CONTRACT

Beth Keeney presented the commissioners with a Zillow Contract for data extraction. Commissioner Brewer motioned to approve the contract, Commissioner Timmons seconded. Motion carried 3-0.

IN THE MATTER OF AREA PLAN UPDATE AND LUPAC#02-21-360

Liz Stitzel reported that she is working with Tom on the bid for removing the Manson Elevator. Liz presented Lupac#02-21-360 rezoning 10.68 acres of land from the A-1 Agricultural Zoning District to the R-2 Low Density Residential Zoning District. Commissioner Timmons motioned to approve Lupac#02-21-360 and Ordinance 2021-02 amending the unified development ordinance. Commissioner Brewer seconded. Motion carried 3-0.

IN THE MATTER OF HIGHWAY UPDATE

Rick Campbell reported that he needed Tom to draft a speed limit ordinance for county road 250 W for 400 feet each side of the bridge #55. Tom will draft the ordinance when he returns from vacation.

IN THE MATTER OF OLD BUSINESS

Phil Triplet representing Levi Schimmel requested an amendment to Ordinance 2021-01 to reflect Alexander's addition as opposed to the Original Plat. Commissioner Timmons motioned to approve Ordinance 2021-01A, seconded by Commissioner Brewer. Motion carried 3-0.

Commissioner Timmons motioned to approve Letter Authorizing Tom Little to sign and execute any documents on behalf of Clinton County necessary to carry out the sale of the Main street properties, seconded by Commissioner Brewer. Motion carried 3-0.

Commissioner Brewer stated the Commissioners had accepted a bid for snow removal from Smith's Lawn Care but did not put a time frame on the bid of 1 or 3 years. Commissioner Timmons motioned to approve a 1 year contract, seconded by Commissioner Brewer. Motion carried 3-0. Tom will need to draft a contract when he returns.

IN THE MATTER OF NEW BUSINESS

Commissioner Timmons motioned to approve the HIPAA PHI Election Compliance Certification, seconded by Commissioner Brewer. Motion carried 3-0.

Commissioner Timmons motioned to approve the Conflict of Interest Statement for Jordan Brewer, Commissioner Uitts seconded. Commissioner Brewer abstained. Motion carried 2-0.

Rhea Harris requested that she be able to fill an open position by turning 2 part-time positions into 1 full-time position. It is already in the budget. Commissioner Brewer motioned to approve, Commissioner Timmons seconded. Motion carried. 3-0.

Sheriff Rich Kelly reported that they had 58-59 Federal Inmates and will remain around that number. They have had 2 resignation and need to fill those positions with merit deputies. The garage door going to the basement needs to be replaced. They will be replacing 4" copper pipe with pvc and their maintenance department will do the work themselves.
