IN THE MATTER OF PLEDGE OF ALLEGIANCE

IN THE MATTER OF PUBLIC COMMENT no public comment was received.

IN THE MATTER OF HIGHWAY DEPARTMENT

Kevin Myers reported: Installing culverts on 100 North. Repair work on tile Hauling Stone and Patching.

Commissioner Woods states there was a complaint about a culvert on 800, may need more information about his.

Liz Stitzel reported: Mowing citations are going out. Reynolds house is in progress of coming down. Dunham property should be coming down in the next couple weeks. Old Sedalia Schools almost completely down. Tom will have to file to take off old penalties .

Commissioners held an executive session on an employee matter. Commissioner Shoemaker motioned for the EMS Director, Greg Miller to properly handle the employee matter at the EMS facility, Commissioner Woods seconded, motion carried 2-0

Sheriff Kelly presented Commissioners with proposal for the new camera system from Apex Security Systems LLC. The proposed amount is \$194,880.00 from Apex and \$14,005.45 for ACCS to upgrade fiber optics. There was discussion on how this would be paid for. Commissioner Shoemaker states it is a rainy day fund issue and should be funded this year. Commissioner Shoemaker motioned for this matter to go in front of the Council at their next meeting on July 9th. Commissioner Woods seconded. Motion carried 2-0.

IN THE MATTER OF DEPARTMENT REPORTS

Chris Overman reported Hinshaw fixed the roofs that were damaged by wind. ARC fixed the windows and framing. Hinshaw will fix about 100 spanish tiles on roof that are cracked or missing. There are about 100 tiles in the basement. The porch that nobody uses will be fixed cheapest route possible.

Sheriff Kelly reports that their budget has been prepared and will add the camera system to it. They are installing an electronic visitation system. Inmates will be able to have video visitation with their attorneys. Body scanner is working great. Chillers have been replaced and working great.

Renee Crick reports: Having interviews today for 2 positions and will submit names to Commissioners soon. There were some issues between Nixle and National Weather Service sending out late warning or watch or not sending at all. The issue has been resolved.
