CLINTON COUNTY CENTRAL DISPATCH BACKGROUND RESEARCH AND TESTING AUTHORIZATION

Consent to Conduct Background Investigation

As a condition of and in consideration for Clinton County Central Dispatch's consideration of my application for at-will employment, I give permission to Clinton County Central Dispatch to investigate my personal and employment history. I understand that this background investigation will include, but not be limited to, verification of all information on this application, as well as interviews with past employers. I further give permission to Clinton County Central Dispatch to conduct this investigation and to discuss the results of this investigation in connection with my application for employment.

Consent to Contact Past Employers

I give permission to Clinton County Central Dispatch to contact all employers listed in my application for references. I further give permission to all current or previous employers and/or managers or supervisors to discuss my relevant personal and employment history with Clinton County Central Dispatch.
