### IN THE MATTER OF PUBLIC COMMENT

#### IN THE MATTER OF HIGHWAY UPDATE

Kevin Myers reported: The steel grate bridge on CR 800 W is almost finished. Hopefully it will be open this week. Started work on the budget for 2020. Hoping for a new patcher, a larger service truck for the drainage crew, a new shop truck, and maybe a new pickup.

Hope to be able to finish spreading in about a week. The wet weather has really set us back. Our dust control program should begin soon after we get done spreading. Not sure when chip sealing starts. We have been swamped with problems with drainage tiles, culverts and other issues.

Sent specs for the 2019 single axle truck. This will be used as a patcher truck, and to plow snow. The new tandem that we have been waiting on is now being fitted with trailer towing package at Stoops. The truck was basically ready until we changed its use.

Kevin presented the Commissioners the CCMG Grant for Forest, the proposed plans for chip sealing, conversions, and cold mix. Also attached is the CCMG for CR 100 N, I doubt with all the delays because of weather, that 100 N gets done this year, depends on who gets the bid and the weather.

#### IN THE MATTER OF AREA PLAN

Liz Stitzel reported: There are two properties that will need mowed. Properties at 6998 N SR 29 and 7049 N. SR 29. A property listed at 3706 S SR 39 that either needs a lien or Condemned. Commissioner Shoemaker motioned to put \$150.00 lien on property. Commissioner Woods seconded. Motion carried 3-0.

Liz request that the commissioners consider doing an emergency amendment to the Unified Development Ordinance that would allow state accredited schools to have preschools. Commissioner Uitts states that the Elevator property in Mansion that is owned by the Redevelopment Commission needs mowed. Liz will send the county mower to mow.

Commissioner Woods updates on Dunham property on SR 29, that it is scheduled to come down at the end of June. Liz will schedule inspection. Commissioner Woods comments on Sedalia schools in good shape and any receipts the gentleman turns in should be taken off the tax lien. Carol states she hasn't seen any as of yet.
