The Clinton County Commissioners met for a special meeting on February 5, 2018 at 9:00 a.m. in the Commissioners' Meeting Room located at 125 Courthouse Square, Frankfort, IN 46041.

## IN THE MATTER OF HIGHWAY

Highway Superintendent Kevin Myers presented the following report:

## IN THE MATTER OF VACATION OF ALLEY

Adam Rich requested an alley be vacated in the middle of his property in Boyleston. There are no utilities in the alley and the adjoining property owners have been notified.

Commissioner Shoemaker moved to vacate the E. St Mary's Street and alley in Boyleston . Commissioner Woods seconded. Motion carried 2-0.

## IN THE MATTER OF GUTS AGREEMENT

Commissioner Shoemaker moved to approve ADDENDUM between the Clinton County Board of Commissioners and Government Utilities Technology Services, Inc. for a two year period. Commissioner Woods seconded. Motion carried 2-0.

Treasurer Carol Bartley noted the sewer gas smell in her office gets worse in the afternoon.

## IN THE MATTER OF CENTRAL DISPATCH

Director Renee Crick presented the 2017 annual report including statistics and their 2018 goals. Commissioner Shoemaker commended Ms. Crick on improvements made to the department. The Commissioners had no objection to the hiring of a new employee.

## IN THE MATTER OF FAIR COUNCIL

Lee Anthrop presented the American Structure Point Services Agreement for property condition assessment and feasibility study for the Clinton County Fairgrounds. Commissioner Shoemaker will request an additional appropriation from the Council from the Landfill Tipping Fee fund for payment

Commissioner Shoemaker moved to approve SERVICES AGREEMENT in the amount of \$47,850.00. Commissioner Woods seconded. Motion carried 2-0.

## IN THE MATTER OF PUBLIC COMMENT

Commissioner Woods asked for public comment

Tim Wyrick thanked the commissioners for the job they do and asked for clarification on wind farms in Clinton County. Wind farms would solve financial issues for the county and schools. EON energy has pledged county income of \$3,000,000 per year and this would set the county on an undeniable path to security. He also reported that CR 100 N. was burmed but not completed properly and these issues will not be fixed due to funding. He requested the Commissioners set a date to meet with EON Energy.

Brenda Robertson stated she appreciates the Commissioners holding the moratorium and asked them to look into funding prior to making a decision on wind farms.

Attorney Alex Bruggenschmidt reported he works with blighted properties and presented an agreement to assist the County at a cost of \$500 per parcel plus expenses.

Commissioner Shoemaker moved to approve Agreement for Tax Sale Legal Services with Buchanan & Bruggenschmidt, P.C. Commissioner Woods seconded. Motion carried 2-0.

Commissioner Shoemaker moved to allow Buchanan & Bruggenschmidt to proceed with providing legal services for the two Manson elevator parcels and the Sycamore Run parcel. Commissioner Woods seconded. Motion carried 2-0.
